# **Privacy Policy**

This Privacy Policy ("Policy") applies to alfeeconsulting.com, and ALFEE CONSULTING ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include alfeeconsulting.com. The Company's website is a CMO Consulting Service site. ### **Collection of your Personal Information**

# **Use of your Personal Information**
